No less than 3 months proration allowed.

***9 Hole Memberships** may only play 9 holes per day. Pro Shop has discretion as to front or back nine due to availability.

***Intermediate Memberships** are subject to a trail fee of \$7.00 per round when using a personal cart and \$11.00 when using a golf cart furnished by Zellwood Station Golf Club.

Participation Agreement: I understand that my membership is for 2010 (2009-2010 Seasonal Membership only). I irrevocably agree to pay the dues set forth for an entire year/6 month period (Seasonal Memberships only). Any exemptions can only be granted by the Co-Op board. No first quarter annual fees/half payments for seasonal membership shall be accepted unless accompanied with this signed document stipulating that the resident acknowledges the financial obligations of an Annual/Seasonal fee golf privilege. If the applicant agrees to pay quarterly other than for a Seasonal Membership, payments must be received at the beginning of each of the four (4) quarters totaling the full amount of the Annual Fees listed in this agreement. All persons who are in arrears in the payment of the full amount of the annual fee/seasonal fee by agreement end date shall forfeit the participation the quarterly, semi-annually, or any other payment arrangement for the following year. In order for such persons to retain the benefits of a dues paying member, full payment must be tendered with that year's application, in addition to the full amount of the unpaid arrearage. Payments later than 15 days passed the start of a quarter will incur a late fee of \$50.00
